**ORDER GRANTING APPLICATION FOR  
APPROVAL OF FEES AND EXPENSES**

On this day, the Court considered the *Application for Approval of Fees and Expenses* ("*Application*") filed by Jean G. Johnson, Special Deputy Receiver of Universal HMO of Texas, Inc., ("Special Deputy Receiver.") The Special Deputy Receiver appeared through her counsel. Although duly and timely notified of the *Application*, no one else appeared on behalf of any other party in interest.

Having considered the *Application*, the evidence, the argument of counsel, if any, and the recommendation of Tom Collins, the receivership master acting under the *Order of Reference to Master* ("receivership master,") entered on May 22, 2013 ("*Order of Reference*,") the Court finds as follows:

1. This Court has jurisdiction to hear this matter, and jurisdiction is properly in the 345th Judicial District Court of Travis County, Texas, as the court in which these delinquency proceedings are pending pursuant to TEX. INS. CODE ANN. § 443.005(c);
2. The subject matter of the *Application* and the hearing of any objections to the *Application* have been referred to the receivership master appointed by this Court in this proceeding, in accordance with the *Order of Reference* under Paragraph III (5), (6), and (15);

3. There were no objections filed to the *Application* before the receivership master;
4. The Special Deputy Receiver is authorized to file the *Application* pursuant to TEX. INS. CODE ANN. §§ 443.015, 443.016, and 443.154(a);
5. The *Application* was properly submitted for hearing by submission before the receivership master in accordance with the *Order of Reference*;
6. The notice given of the hearing for the *Application* complied with the length of notice requirements in the *Order of Reference*;
7. The notice given of the hearing for the *Application* to the certificate of service complied with the breadth of the notice requirements in TEX. INS. CODE ANN. §§ 443.004(a)(17) and 443.007(a) and (d) and in the *Order of Reference* and is sufficient;
8. The notice given of the hearing for the *Application* to the certificate of service complied with the means of notice requirement set forth in the *Order of Liquidation* entered on May 17, 2013;
9. The evidence submitted supports approval of the *Application*;
10. The receivership master has issued a recommendation that the *Application* should be granted pursuant to Rule 171 of the Texas Rules of Civil Procedure
11. The recommendation of the receivership master should be confirmed, and the *Application* should be **GRANTED**.

It is **ORDERED, ADJUDGED** and **DECREED** that:

1. The *Application* is approved in all respects;
2. Exhibit A, the *Affidavit of Jean G. Johnson*, is admitted into evidence;
3. Exhibit B, which sets forth the rates for compensation, is admitted into evidence;

4. The facts contained in the *Application* and its exhibits are admitted into evidence as *prima facie* proof of the matters asserted pursuant to TEX. INS. CODE ANN. § 443.017(c);
5. All terms of compensation pursuant to TEX. INS. CODE ANN. § 443.015(d) and rates for compensation as set forth in Exhibit B are approved;
6. Quarterly reporting periods will be established that coincide with the State of Texas fiscal year, which runs from September 1 to August 31;
7. Quarterly reports will be filed by the 15th day of the month following the end of the quarterly reporting period, with the first reporting period to cover April 2013 to May 2013;
8. The first quarterly report will be filed by June 15, 2013;

It is **FURTHER ORDERED** that the Special Deputy Receiver is authorized to execute any documents and to incur any expenses as necessary to effectuate the purposes of the *Application*.
